Hydrogen sulfide is a human poison by inhalation. A severe irritant to the eyes and mucous membranes. An asphyxiant. The irritant action has been explained on the basis tha hydrogen sulfide combines with the alkali present in moist surface tissues to form sodium sulfide, a caustic. Hydrogen sulfide does not combine with the hemoglobin of the blood; its asphyxiation is due to paralysis of the respiratory center. It is an insidious poison sense of smell may be fatigued. The odor and irritating effects do not offer a dependable warning to workers who may be exposed to gradually increasing amounts and therefore become used to it. RTECS: No data
